#### **Functions:**

Paschimbanga Jatra Akademi is an organization under the direct control of the Information & Cultural Affairs Department, Government of West Bengal. The akademi works solely for development of 'jatra' and its fraternity by way of –

- a) Offering financial assistance to the aged (60 years & above), financially marginalized and retired jatra artists and technicians as well as to the physically challenged, financially weak aged 45 years & above jatra artists and technicians.
- b) Recognising jatra stalwarts namely 'Shantigopal & Tapan Kumar' and conferring award to eligible jatra personalities in their names
- c) Organizing 3 days District Jatra Festival and engaging jatra troupes to perform in all the 22 districts in the state
- d) Organizing month-long Jatra Festival at the State Level.
- e) Organizing workshops for neo talent search and skill development
- f) Revenue generation for Phanibhushan Bidya Binod Jatra Mancha

## (2) Power & Duties of its officers and employees: [u/s 4(1)(b)(ii) of RTI Act,2005]

#### **Powers:**

Secretary, Paschimbanga Jatra Akademi, is the executive head of the Akademi for implementation of the recommendations as made by the General Body of the Akademi formed in the year 2005 by the Government of West Bengal and as approved by the Administrative Department.

Secretary, PBJA being the designated DDO for the academy is assigned to draw and disburse for all the expenditure as per Delegation of Financial Power Rules, 1977 as amended from time to time. Power and duties of the officer is clearly defined by the different rules as described primarily in West Bengal Service Rules Part-I & II, West Bengal Financial Rules, West Bengal Treasury Rules including procedure to execute work.

Secretary, Paschimbanga Jatra Akademi is the Head of the Office and her service is placed under the control of the Director of Culture, I&CA Department
